**RECONSTITUTION OF MEMBERSHIP OF THE GENDER AND DEVELOPMENT
FOCAL POINT SYSTEM**

1. In the interest of the service and in compliance with Philippine Commission on Women (PCW) Memorandum Circular No.2016-04, the members of the Office for Transportation Security, Gender and Development Focal Point System (OTSGFPS) is hereby reconstituted.
